संदर्भ: Samiti's circular F.No.2-2/2018-NVS(Estt.II)/17464 dated 6.4.2018.


महोदय/महोदया,

Enclosed herewith please find Samiti's circular under reference vide which it has been intimated that Annual Transfer Drive for 2017 has already come to an end and that representations of all the cadres of employee received on the consequence of final transfer list of all cadres have duly been considered and disposed off on merit and relevant orders to this effect are being issued for compliance. In view of the foregoing, the following instructions have been communicated for strict compliance:-

1. No representation in any case of any cadre of employee, henceforth, will be entertained by NVS HQrs regarding transfer pertaining to Annual Transfer Drive of 2017.
2. All those transfer orders which were issued in 2017 with an instruction that the orders would come into effect after 31.03.2018 would now be treated as have come into effect. Therefore, extension given to any employee against his/her transfer, upto end of the academic session 2017-18 ends now. Similarly, orders for attachment of any employee to other JNV till end of the academic session 2017-18 also comes to an end. Consequently, representation regarding further extension of period for joining and /or continuation of attachment, if any, submitted to HQrs will not be entertained.
3. Principals are therefore requested to relieve such employees whose transfer/extension orders have already been issued but relieving is kept in abeyance, shall now relieve such employees immediately after 15th April 2018 so as to enable them to join their actual place of posting.
4. Any inaction on the part of the Principals in this regard will be viewed seriously and will be dealt with accordingly.

Principals are therefore requested to strictly comply with the instructions and action taken may be intimated to this office for further transmission to HQrs Office.
