Sir,

As you are aware, a group of NVS Employees has issued a notice for staging a Dharna on 22nd April, 2015 at NVS Hqrs. to press the demand of according recognition to the Staff Associations.


It is to inform that Samiti is taking sincere steps within the framework of the Samiti as per Government of India guidelines to accord recognition to the Staff Associations. It is unfortunate that a group of employees is trying to mount undue pressure on the authorities, despite knowing that the demand for recognition of staff association is under active consideration of NVS. The action of staging Dharna at this juncture is highly unjustified.

It has been decided that no employee will be allowed to proceed on any kind of leave on 22nd April, 2015, except on medical ground (duly supported by necessary documents). Any action on the part of the employees for staging Dharna and jeopardizing the activities of the Navodaya Vidyalaya Samiti by skipping the duties would tantamount to mis-conduct on their part and their absence from the duties would be treated as unauthorized absence resulting in loss of pay and other consequences as per rules.

You are requested to kindly bring these instructions to the notice of all employees of your region for strict compliance.

Action taken for the compliance of the above instructions may be intimated to NVS (Hqrs.), immediately. A list of employees, if any, who remains absent from duties on 22nd April, 2015 may be forwarded to this office by the after noon of same day.
