### कार्यालय आदेश

In pursuance of Samiti's Circular(s) F.No.2-119/99-NVS(Estt.) dated 06.11.2000, 31.05.2002, 31.10.2002, 30.09.2003, 25.02.2005, 23.11.2007, F.No.2-119/99-NVS(Estt)/1813 dated 28.04.2010 & Clarification F.No.1-7/2012/NVS(Estt)/Legal/1518 dated 9.12.2013 regarding granting of Senior Scales to PGTs(promoted from TGTs after completion of 12 years from the date of promotion) at par with PGTs who are appointed on direct recruitment basis and on the basis of the recommendations of the Departmental Promotion Committee meeting held on 17, the following teaching staff of the JNVs of Hyderabad Region with 12 years of regular service are hereby granted **Senior Scales w.e.f. the date mentioned against each in the list enclosed as detailed under:-**

The Pay in respect of the teachers granted Senior Scales vide this order shall be fixed under the provisions FR-22(I)(a)(2) as per their option (either direct from the effective date of Senior Scales or from the Date of Next Increment ) to be exercised within one month.

Accordingly, pay fixation proposal in respect of the teacher(s) concerned, duly signed by the OS/UDC and countersigned by the Principal, alongwith the following documents may be forwarded to this office within 30 days for approval :-


- Option form duly signed by the teacher & countersigned by the Principal.
- Photocopy of the relevant page of Service Book in support of date of joining the Samiti in case of Direct Recruittee PGTs & TGTs & date of promotion of PGTs duly attested by the Principal.

- (c) Photocopy of the relevant page of Service Book containing the entry regarding pay drawn as on effective date of Senior Scales duly attested by the Principal.

The date of grant of Senior Scale has been postponed for the period of strike/dies-non/EOL(Private Affairs) etc as intimated by the JNVs. The date of grant of Senior Scale has been arrived on the basis of the information provided by the vidyalaya. However, before issue of pay fixation order all the dates may be verified and the following may be adhered to while fixing the pay with regard to strike period:-

- (a) In the cases where the strike period has been regularized by granting leave of the kind due and admissible as envisaged in Samiti's circular No.12-1/2017-NVS(GA) dated 31/10/2017, the effective date of Senior Scales may reckoned w.e.f. date of completion of 12 years from the date of joining eg. in case of date of joining the post is 29.05.04 then the effective date shall be 29.05.2016 and the pay fixed accordingly.
- (b) In the cases where the strike period has not been regularized by granting of leave of the kind due and admissible, the effective date of Senior Scales shall be as shown in the order and pay fixed accordingly.
- (c) In case, if it is found that the strike period has not been taken into account in some cases, the effective date of Senior Scales shown in the order may be postponed to that extent and made effective from the postponed date and pay fixed accordingly.

**Further, prior to fixation of pay of the teachers sanctioned Senior Scales vide this Office Order, cases of promotion refusal, factual errors in date of joining, effective date of Senior Scales, Pay scales, name, Designation, JNV mentioned against each etc, observed if any, may be brought to the notice of this office for necessary rectification.**
