Sir/Madam,

Kindly refer to Commissioner, NVS Hqrs letter No.10-69/2015/NVS(SA)/84, dated 26.10.2016 on the above issues. The Commissioner, NVS is very much concerned about unrest/indiscipline among the students which are on rise on different issues mainly concerning food, stay and behavior of staff and also groupism among the teachers and students which has detrimental effect on academic environment of the Vidyalaya. The Commissioner has suggested that above issues can be resolved by conducting regular PTC, Mess Committee Meetings, VMC meetings, Meetings of Alumni Students, Continuous interaction of Principal, House Masters and Associate House Masters with the students. Further it has been desired by the Commissioner that all the Principals, Vice Principals and Staff may follow the following rigorously with proper documentation:

1. School Complaints Committee to be chaired by Principal, shall meet at least once in a month to consider all complaints received during the period.

2. PTC shall meet at least once in three months so that concern of parents and their assistance in resolving the issues could be considered.
3. VMC meetings shall be convened regularly as per the norms and as per the convenience of the district Collector.
