Sir/Madam,

The purchase procedures for procurement of all essential items like grocery, uniform, daily use items for students, bedding items, stationary items, furniture, sports material and all other items which are required for the students and the Vidyalaya must have been completed by now. It is also believed that final rates must have been already finalized for different items by following the tender process for the financial year 2016-17, with the approval of Purchase Advisory Committee of the JNV. It has been observed that there have been complaints and apprehensions regarding the quality of materials purchased and procured. The Samiti has been receiving several complaints through different sources and Honorable Minister for HRD and Commissioner, NVS has taken a serious view on such complaints. In order to make it more transparent it is desired that every JNV should display the approved rates of different items that are procured for day to day maintenance and also for the functioning of JNVs on their web sites with immediate effect so that the apprehensions would be addressed effectively. Once it is on the public domain it will open to every body to check and cross verify the approved rates with prevailing market rates. The following format is suggested to upload the lowest rates approved along with the quality of items procured.

The Hon'ble Minister of HRD and Commissioner, NVS may like to verify the rates directly from the web sites of the concerned JNVs any time after 3rd July 2016 to know the lowest approved rates as approved by PAC. Since the above information once displayed will be accessible to the public and officers sufficient care should be taken while displaying the above information and ensure that the information displayed on the web site is correct. Principal and Office Superintendent should bestow their personal attention. Any deviation or delay in displaying the information on the web sites of the JNVs will be viewed seriously and action as deemed fit will be initiated. Kindly acknowledge the receipt of this letter.
