विषय: Payment of revised remuneration to the teaching & non-teaching staff appointed on contract basis in the Samiti.

संदर्भ: Samiti's letter F.No.12-17/2002-NVS(Estt.I) dated November 28,2013.

महोदय/महोदया

Samiti vide its letter under reference & printed overleaf, has instructed that in addition to the existing system of engaging teachers on short-term contract, the services of good and willing teachers of the Samiti may also be taken on contract basis, after their retirement. Such teachers who are physically and medically fit and have a good service record, may be given preference in the matter of appointment of teachers on contract basis as per requirement, up to a maximum age of 62 years against the available vacant posts or till a regular incumbent joins whichever is earlier.

Further, the consolidated remuneration being paid to the teachers appointed on contract basis has been enhanced as under:-

S.No.	Name of post	Existing remuneration	Revised remuneration (with effect from 1 st November 2013)
1.	PGT	Rs. 21,300/-	Normal stations -- Rs.27,500/- pm Hard station – Rs.32,500/- pm
2.	TGT	Rs. 20,000/-	Normal stations – Rs.26,250/- pm Hard station – Rs. 31,250/- pm
3.	Matron	As per the minimum wages fixed by the Labour Department of the concerned State Government/UT	Rs. 7,500/- pm

The revised rates will be applicable with effect from 1st November 2013.

The revised remuneration is payable to the above categories of contract employees who are fully qualified and appointed by following due selection procedures on full time contract basis against a vacant sanctioned post in a Vidyalaya for 10 months in a academic year. All other conditions regarding engagement of teaching & non-teaching staff on contract basis will remain unchanged.
